HONORING PAMELA Z. BALDASSARRE

Dr. Pamela Z. Baldassarre will be honored as the recipient of the Thomas F Winkler Leadership Award for her leadership and dedication to our profession and to the New England Section at the 2023 American College of Dentists New England Section (ACD) Annual Meeting and Awards Luncheon Dr. Baldassarre

Dentists New England Section (ACD) Annual Meeting and Awards Luncheon. Dr Baldassarre was inducted into Fellowship in the American College of Dentists in 2009. In 2010 she was appointed to the Board of Directors of the New England Section and served with distinction as the Vice Chair in 2012 and the Chair from 2013-2015.

Dr. Baldassarre received her D.M.D. degree from the Boston University Henry M. Goldman School of Dental Medicine in 1982. She subsequently completed a residency in periodontics at the Boston University Goldman School of Dental Medicine and received her Certificate of Advanced Graduate Studies in 1984. A third generation dentist, she entered the private practice that had been her father's, in Framingham, MA. Dr. Eliot Zigelbaum, had been inducted posthumously as a Fellow in the ACD in 1983. She then moved to Merrimack, NH to practice periodontics full-time, sharing an office with her husband, Dr. Marshall Baldassarre,

an oral and maxillofacial surgeon. They have resided in Bedford, NH with their family for the past 30 years.

Dr. Baldassarre first became involved in dental education as a pre-clinical instructor at B.U. in the pre-doctoral

periodontics curriculum. Subsequently, she became a volunteer clinical instructor for postgraduate periodontics, also serving as a guest lecturer for the NH Technical Institute School of Dental Hygiene. Since that time she has provided numerous continuing education programs and study clubs for local dentists and their staffs.

Dr. Baldassarre has been actively engaged in organized dentistry. She has served as the Secretary of the West

She has served as the Secretary of the West Metropolitan Dental Society in Massachusetts, President of the Nashua Dental Society, and Trustee for the Greater Nashua Component of the New Hampshire Dental Society (NHDS). She has been a member of the Council on Continuing Education for the NHDS, the Chairperson of the Nashua Dental Society Peer Review Committee, and a member of the State Peer Review Committee as well.

She served as Chairperson of the State of New Hampshire's interdisciplinary task force "New Hampshire Health Professionals for Healthy School Nutrition" from 2001-2005. This was one of the first interdisciplinary task forces for the State of New Hampshire including dental health professionals, physicians, and representatives from the Department of Education, Health, and Human Services. She was the author of the "Soft Drink Toolkit" and coauthor of the power point educational presentation available statewide to promote healthy food and beverage choices in the schools. The task force was recognized nationally and by the state for its accomplishments.

Dr. Baldassarre served on the Board of the New Hampshire Dental Society (NHDS), becoming the first female President of the NHDS in 2002-2003. She contributed to implementing strategic planning and was the author of the statewide political action committee initiative presentations for "Legislative Nights", a program presenting legislation facing dentistry and the State of New Hampshire to each local component. This was well received by both dental practitioners and state legislators. She served as the Delegate at Large for the NHDS for the ADA from 2006-2012 and Secretary/Treasurer for the ADA First Trustee District from 2008-2012.

Among the many awards and appointments she has received over the years, Dr. Baldassarre served on the ADA Council on Membership from 2004-2008, elected as Chair. She had the honor of being appointed to the reference committee for the Membership and Communications Committee for the 2002 ADA House of Delegates and then received the ADA Presidential Appointment to the ADA Task Force for Curriculum Development for oral preventive assistants. In 2009, she received the Distinguished Alumni Award from the Boston University Goldman School of Graduate Dentistry followed by an appointment to the Boston University Alumni Council in 2011. She was honored to be nominated and inducted into the International College of Dentists. She holds close to her heart the mission and vision of the American College noting that this is what defines us as true professionals and is paramount.

Dr. Baldaassarre's dedication to our profession, professional education, and her steadfast commitment to the principles defined in the ACD Mission Statement are exemplary. It is an honor for us to bestow the Thomas F. Winkler Award on her.

The nominees are then reviewed by a committee of the ACD Board without knowledge of the name of the nominee, the nominator or the seconder.

The deadline for nominations for induction at the next annual meeting is January 15, 2023. The nominating forms and the profile summary can be downloaded through the ACD website after logging on to the Members Section and completed after obtaining the curriculum vitae. The completion of the forms requires a statement from the nominator and should be seen

by the seconder. The statement is a critical part of the process for the committee reviewing the Fellowship application. Please do not forward any part of the completed application materials to the person being nominated as that is a violation of the ACD confidentiality requirement. New England Section YDC Panel Discussion Presentation

Multidisciplinary Treatment Planning in Recognizing and Resolving Ethical Issues

Dentists face professional and ethical dilemmas on a daily basis. Along with dentists, dental hygienists and dental assistants participate in the resolution of these dilemmas as part of the dental team. On Thursday, January 26, 2023 the New England Section will present the above titled course, continuing its series of clinical ethical/legal presentations at the Yankee Dental Congress. The panel discussion will focus on the recognition of treatment planning shortcomings with the corresponding potential for risk management issues. By using actual clinical cases that involve multi-disciplinary treatment planning approaches, this course will encourage audience participation (dentists, hygienists, assistants) in order to demonstrates how to recognize ethical dilemmas and how these concerns were actually addressed with subsequent clinical treatment. Certain legal as well as the risk management ramifications of the treatment avoided as well as the treatment rendered will be discussed.

Course attendees will be able to:

- 1. Understand how the dental team (dentist, hygienists, assistants, and front desk managers) can work together to recognize ethical dilemmas guided by the ADA Ethical Principles.
- 2. Recognize how the dental team addresses patients' concerns about treatment to resolve ethical dilemmas.
- 3. Utilize interdisciplinary treatment planning to help limit ethical issues and treatment problems.
- 4. Examine ways to render subsequent clinical treatment that can mitigate risk problems and legal concerns.
- 5. Determine how to strengthen the dental team's risk management skills.

The panel participants will be:

Dr. Julie Connolly, DDS, is a Board Certified Periodontist in New York, New York. She is the Director of Ethics Course work at the Columbia College of Dental Medicine where she is an Assistant Professor in the Department of Periodontics. She is also a Fellow and Chair- Elect of the New York Section of the American College of Dentists and became Regent of Regency 1 of the ACD in October 0f 2022.

Vincent Dunn, Esq, JD has over twenty five years of diverse trial experience in Massachusetts and New Hampshire, concentrating his practice on healthcare professionals and institutions in civil, criminal, and administrative matters. He has routinely appeared in the state and federal courts, before Boards of Professional License Registration, and at regulatory and credentialing hearings and investigations. He lectures widely on risk management, regulatory compliance, administrative procedure and professional licensing issue.

Dr. Howard Hill, DDS is a Past Chairperson of the New England Section and maintains a full-time restorative practice in Georgetown, MA.
